**NOTICE OF UNITED STATES POSTAL SERVICE OF

The United States Postal Service hereby provides notice of filing the completed certification for postal counsel not present at the August 28-29 session of the deposition of Jessica Dauer Lowrance. This certification is associated with the Postal Service's Motion for Clarification regarding access to the transcripts of the Lowrance deposition, filed on September 11, 2008. In that Motion, the Postal Service stated it was "hereby providing" said completed certification. However, undersigned counsel inadvertently failed to attach the certification to the final PDF version of yesterday's filing.

Thus, the completed certification is attached to today's notice pleading. Ultimately, the attached certification may be a moot point, given the fact that the Postal Service's Motion for Clarification requested relief from filing certification forms for postal personnel to obtain access to the Lowrance deposition transcript, and the Postal Service was able to obtain the consent of counsel for Capital One on this matter. Nevertheless, the Postal Service is today filing the attached certification, to correct yesterday's accidental exclusion.
