(March 16, 2009)

In conjunction with a supplemental response to Question 7 of Commission Information Request No. 5 filed on March 13, 2009, the Postal Service filed a zip file under seal as USPS-FY08-NP36. As the March 13 notice of filing regarding that material indicated, however, the purpose of furnishing the material under seal was to allow pursuit of an inquiry regarding the potential applicability of a nondisclosure agreement. That inquiry has now concluded, and the determination has been made that the contents of the zip file are suitable for public disclosure. The zip file is therefore attached to this pleading electronically. The zip file includes the spreadsheets which document the FY 2008 financial impact evaluation of the Bank of America NSA summarized in the supplemental response to Question 7 of CIR No. 5.
