FOR ADJUSTMENT OF BRIEFING SCHEDULE TO ACCOMMODATE
THE STIPULATION AND SETTLEMENT
(September 15, 2004)

The Postal Service, Bank One Corporation, and the Office of Consumer Advocate respectfully request the Presiding Officer to adjust the briefing schedule in this case to accommodate the Stipulation and Settlement, which was filed today. Pursuant to Presiding Officer Ruling No. 3, issued on August 25, 2004, the Initial Briefs in this case are due on September 20, 2004, and reply briefs are due on September 27, 2004.
