PRESIDING OFFICER'S RULING AMENDING  
PRESIDING OFFICER'S RULING NO. 21

(Issued July 24, 2006)

Presiding Officer's Ruling No. R2006-1/21 establishing the schedule for hearings to receive the direct case of the Postal Service was issued earlier today. A previously filed Motion of the Greeting Card Association Regarding Scheduling of the United States Postal Service's Witnesses Thress and Bernstein for Oral Cross-Examination was not adequately accommodated by Presiding Officer's Ruling No. 21.

The schedule for hearings is hereby amended. Witnesses Mayes (USPS-T-25) and Kiefer (USPS-T-36) will appear on August 8 instead of August 9. Witnesses Thress (USPS-T-7) and Bernstein (USPS-T-8) will appear August 9 instead of August 2. The testimony of Witness Davis (USPS-T-47) will be received in evidence August 3.
