PRESIDING OFFICER'S RULING  
SCHEDULING WITNESSES

(Issued October 6, 2006)

The schedule for the appearance of witnesses presenting the direct case of participants other than the Postal Service, including rebuttal to the Postal Service, is set forth in the Attachment to this ruling. Hearings each day will begin with the witnesses scheduled to appear on that day following the order appearing in the Attachment. Hearings normally will continue until cross-examination of all scheduled witnesses is completed. Participants requesting an exception to this procedure will be expected to contact all counsel representing a scheduled witness or indicating an intent to cross-examine witnesses scheduled to appear on that day prior to making such a request.

All witnesses are scheduled although no participant filed preliminary indication of intent to cross-examine witnesses sponsored by Douglas F. Carlson, The Flute Network, and Discover Financial Services & Morgan Stanley, Inc. Those witnesses are excused from appearing, subject to recall. Participants seeking to orally cross-examine these witnesses must show good cause for failure to provide advance notice. They are identified with an asterisk on the schedule and their testimony will be entered into evidence on the days shown. Sponsoring participants should submit corrected versions of their testimony accompanied by a declaration of authenticity.

On several dates no witnesses are scheduled to appear. Hearings may be held on these dates if necessary to accommodate extended cross-examination, or if there is a need to recall witnesses. As discussed at the prehearing conference, counsel will be

expected to enter a complete, corrected copy of testimony and any sponsored library references into evidence.
