I note that these reports do not include an overall performance report for Standard Mail® NFM/Parcels. However, as outlined in the August 1, 2011, implementation plan, the Postal Service is providing performance data for Standard Mail® NFM/Parcels entered at the Destination Delivery Units. In addition, due to technical complications, the Postal Service is unable to provide service performance data for electronic return receipt with this report. Please note that the Postal Service is continuing to use Standard Post (previously Parcel Post prior to its conversion from a market dominant product to a competitive product) as a proxy for Inbound Surface Parcel Post (at UPU rates).
