FOR EXTENSION OF TIME FOR THE FILING OF OBJECTIONS  
AND ANSWERS TO THE OFFICE OF CONSUMER ADVOCATE'S  
INTERROGATORIES TO UNITED PARCEL SERVICE  
(OCA/UPS-1-12)


United Parcel Service and the Office of the Consumer Advocate hereby jointly move that the deadline for UPS' filing of answers or objections to Interrogatories OCA/UPS-1-12, served by OCA on UPS on June 28, 1999, be extended. The current deadline for UPS' filing of objections is July 8, 1999.

UPS has informally raised certain concerns and questions about OCA's interrogatories, and, as a result, UPS and OCA have undertaken a discussion of those concerns and questions that may obviate the need for UPS to object to some of the interrogatories. In order to permit sufficient time to pursue that dialogue, UPS and OCA jointly move that the deadline for filing UPS's answers or objections be extended. UPS and OCA propose to continue their discussion until such time as OCA provides UPS notice that OCA no longer considers the discussion productive. UPS will commit that within five (5) days of OCA's notice that the discussion is no longer productive, it will file

any objections to the interrogatories. UPS will also commit that within ten (10) days of OCA's notice that the discussion is no longer productive, it will file its answers to those interrogatories to which it has not filed objections. OCA has authorized UPS to represent that OCA joins in this motion.

WHEREFORE, United Parcel Service and the Office of the Consumer Advocate respectfully request that the Presiding Officer grant the Joint Motion for Extension of Time on the terms described herein.
