The Postal Service has informed us of a decision to close our post office by January 1, 2012 (docket # 1377998-65728). This action is being taken after meeting the provisions of the Postal Reorganization Act of 1970 and over our protestations. However, the notice was posted December 16, 2011, and the proposed closure date does not allow for the thirty-day response required.

We, the customers of the Ponce de Leon, Missouri Post Office, vigorously protest this action in view of the provision in the Postal Reorganization Act that calls for the Postal Service to provide a maximum degree of effective and regular postal service to rural areas, communities and small towns where the post office is not self-sustaining.

The Postal Service's decision to close our post office and provide rural delivery service raises questions concerning the sanctity of the mail and the risks involved in noncareer employees handling the mail. We also foresee inconveniences in purchasing money orders and stamps and sending accountable mail. We have the same concerns regarding the receipt of accountable mail, such as certified letters, registered letters and CODs.

There is a contradiction in the final determination letter concerning the Ponce Post Office sales trend. In Section 1. Responsiveness to Community Postal Needs, third paragraph, third sentence, is written "Over the past several years, this office has experienced a steady decline in revenue and/or volume. However, in the 4<sup>th</sup> paragraph, 2<sup>nd</sup> sentence, it states "Revenue has seen a slight increase over the last several years."

Another area of concern is the Postal Service's lack of cogent response to patrons concerns. There is a pattern of relentless insistence that technology will take the place of most of the functions of our post office. The Ponce Post Office does not serve a few city blocks or a tidy section of some small town. The area our Post Office serves is rough hill country, with some unpaved roads, deep hollers, low-water crossings, and extremely limited availability of technology. Some areas still have the original phone lines installed back in the 1950's, so that when it rains internet connection is disrupted. Also, not everyone wants or can afford a computer. The idea that because the technology is intrinsic to business elsewhere means that everyone lives a connected life is a false premise.

The services lost to our community include the only public bulletin board in our community. The response to this comment in all our letters and

petition has been that we will have to use one at a local grocery store, gas station or other business in town. We have all tried to make it clear that the Ponce Post Office is the last public building in town, last public business in town, last meeting place, last vestige of public life in our town. Churches are not left open and unlocked other than for services due to the risk of arson or meth incursion. The bulletin board serves as our public information center, as our Post Mistress serves as the private information hub. She is the person who knows who is ill, who is better, who has troubles, and especially who is to be told, and who is not. Gossip- no. The position of Post Mistress is one of discretion, and she would have little information if she were not trusted to handle it carefully. This communication is a vital thread that keeps our community alive and working together, and will be lost if we lose our Post Office.

Our Post Office cannot be costing the Postal Service a great deal, as it is as frugal as can be. The building is concrete block, with a little one bar heater for the winter, and an open back and front door to cool it in the summer. The hours are limited: just four hours a day, six days a week. The Post Mistress supplies her own office supplies, and even the flag was donated by a neighbor. We are not asking for something fancy and new; we just want to keep what we already have.

The closing of Ponce Post Office would be a hardship for many of the customers due to the increased distance they would have to travel to access services. At the furthest end of the area served the trip to Spokane Post Office would be a round trip of 10 miles. The increased distance and cost will have a prohibitive effect on those who frequently access the post office, especially those who have use the post office for home business transactions, and those who have a post office box. Increased travel costs directly impact the small business bottom line.

We feel that, as citizens of the United States, we are entitled to the same efficient post service provided to our counterparts in urban areas. The Postal Reorganization Act is explicit in pointing this out. We petition you, as member of the Postal Regulatory Commission, to respectfully consider our protest and order the Postal Service to give additional consideration to our service needs.
