Previous Chairmen were under no obligation to retain their travel records after they left the Commission, and they have informed us that they no longer have records detailing their official travel.

The attached summaries, compiled from the United States Postal Service payment archives, will reflect that their travel was part of ongoing Commission domestic and international activity.

We are submitting under separate cover a complete list of Commission field hearings from 2007 to the present.
