**MOTION OF UNITED STATES POSTAL SERVICE
TO DISMISS PROCEEDINGS**

(December 21, 2012)

By means of Order No.1576 (December 12, 2012), the Postal Regulatory Commission (Commission) docketed a correspondence from Karen Toole (Petitioner) on behalf of the City of Climax, Georgia as an appeal, assigning PRC Docket No. A2013-3, pursuant to 39 U.S.C § 404(d). The correspondence, received December 11, 2012, purported to invoke the Commission's jurisdiction to consider an appeal concerning the Climax, Georgia Post Office. Order No. 1576 established December 21, 2012, as the date by which "[t]he Postal Service shall file the administrative record regarding this appeal, "or file "any responsive pleading." This pleading responds to that directive. No Proposal or Final Determination regarding discontinuance of the Climax Post Office has been posted; therefore, the Post Office remains in a status of suspended operation and the Commission lacks jurisdiction to hear this appeal.

Factual Background

As background, Climax Post Office had been a candidate facility within the Post Office Structure Plan (POStPlan).¹ Letters regarding the possible realignment of window service hours and a survey were mailed to customers of the Climax Post Office on September 28, 2012.² The letter explained POStPlan and informed customers that the Postal Service would hold a community meeting on November 8, 2012 to answer questions and provide additional information about POStPlan. In early August, the Postal Service entered lease negotiations with the landlord to renegotiate the lease. However, negotiations failed and the Climax Post Office suspended operations on October 31, 2012.³ As a result of the suspension, the Postal Service initiated a discontinuance feasibility study on November 1, 2012.⁴ In light of the fact that the community meeting had already been scheduled and publicized to the community, the Postal Service held the meeting as scheduled on November 8, 2012. At the meeting, Postal Service representatives discussed the status of the Climax Post Office and informed customers that operations had been suspended due to failed lease negotiations.⁵ On December 4, 2012, the Postal Service mailed customers another letter detailing the reason for the suspension and provided alternate locations where

postal services could be obtained.⁶ The letter also informed customers that the Post Office would be studied for discontinuance while under suspension.

Accordingly, because the Post Office is now suspended, the Climax Post Office is no longer a candidate facility for the POSTPlan initiative, and it is now undergoing a discontinuance feasibility study. The study is still in its early stages and the Postal Service will continue to proceed in accordance with Handbook PO-101 and 39 U.S.C § 404(d) policies and procedures. As such, another community meeting will be scheduled to answer questions and discuss the possible closing of the Climax Post Office. Thereafter, if the Postal Service decides to proceed with closing the office, there will be a formal posting of a Proposal and a Final Determination. Thus, no final decision has been made to close the Climax Post Office.

Argument

Pursuant to 39 U.S.C. § 404(d)(5), “[a] determination of the Postal Service to close or consolidate any post office may be appealed by any person served by such office to the Postal Regulatory Commission within 30 days after such determination is made available to such person.” Pursuant to 39 C.F.R. § 241.3 and Handbook PO-101, the posting of the Final Determination is the appealable event. In this case, no Final Determination has been issued by the Postal Service or been made publically available to customers of the Climax Post Office. As such, no appealable event has occurred.

Because the petition for review filed by the Petitioner, which was received by the Commission on December 11, 2012, was filed prior to both the discontinuance study concluding and the Postal Service issuance of a written Final Determination, the Commission should dismiss the appeal on grounds that it is premature.

As the Commission has previously held, the appropriate remedy for a premature appeal is dismissal. See Docket No. A2011-11 (dismissing an appeal for lack of jurisdiction) and more recently, Docket No. A2012-127 (dismissing an appeal as premature).⁷ The Commission's jurisdiction need not be invoked because the Postal Service has not yet determined whether to discontinue the Climax, Georgia Post Office.

Conclusion

The Postal Service has yet to issue a written Final Determination to discontinue the Climax, Georgia Post Office, and filing of a petition for review by Petitioner before such a Final Determination was issued is premature. Without a Final Determination for the Commission to review, the appeal cannot be adjudicated under section 404(d)(5).

Therefore, the Postal Service requests that this matter be dismissed.

Dear Postal Customer:

The CLIMAX Postmaster retired on 07/31/2012. A noncareer clerk from the office has served as the officer-in-charge since that time. Negotiations with the current landlord started in August to drop the lease to fair market value. The current lease was \$11.84/sqft. The average lease for offices surrounding this office is \$7.43/sqft. FSO countered several times with the last offer of \$8.50/sqft with a 60 day termination clause. The landlord made the last final offer of \$8.75/sqft 5 year term no termination clause and all other terms remain the same.. Therefore, it will be necessary to suspend services at the CLIMAX at the close of business on 10/31/2012. This change is tentative and will not lead to a formal proposal unless we conclude that it will provide a maximum degree of regular and effective postal services.

While the office is suspended, OFFICE WILL BE STUDIED FOR DISCONTINUANCE.. Please contact the postmaster of the for advice regarding the potential placement of mailboxes. Customers presently receiving rural delivery will not experience a change in service, with the possible exceptions of picking up parcels and accountable mail at the that the carrier was unable to deliver. CLIMAX route customers will continue to use CLIMAX GA 39834 as their last line of delivery.

Rural delivery is particularly beneficial to senior citizens, people with disabilities, and working people because no one has to pick up the mail from the post office. You will have 24-hour access to your mail. In addition, the rural carrier can provide all the retail services provided at the CLIMAX. Enclosed is information about some of the services available from the carrier. Most transactions do not require meeting a carrier at the mailbox. Stamps By Mail order envelopes and Money Order Application forms are available for your convenience; or you may place a note in the mailbox, with payment, and the carrier will provide the requested services. When an accountable item requiring a signature, such as a certified letter, cannot be delivered on the first day, the carrier will return the item to the Post Office. You may pick up the article at the Post Office, request redelivery on another day convenient for you, or authorize the carrier to deliver the item to another person.

Customers who wish to obtain Post Office box service may do so at the adminoffice Post Office, located 6.5 miles away. The Post Office has 24-hour lobby access for customer convenience. Window service hours at are 800 to 1230 - 1400 to 1630 Monday through Friday and 800 to 1000 on Saturday. Post Office box lobby hours are adminlobbymf Monday through Friday and adminlobbysat on Saturday. Post Office boxes are available at this location (*check office for fees*). If applicable, Post Office Box refunds can be received at the CLIMAX PO.

Retail services are also available at the Post Office, located 9.3 miles away. Window service hours at Post Office are from nearmfretail, Monday through Friday, and nearsatretail on Saturday. Post Office box lobby hours are nearmflobby.

If you have any questions concerning the placement of rural mailboxes or the services available to you through the rural carrier, please contact the postmaster.

I realize with change there is always concern. No final decision to permanently discontinue the Post Office has been made. A community meeting will be held at or near the in the coming weeks to explain our plans and solicit your comments concerning possible alternate means of providing postal and other services. In the interim, we are confident that carrier delivery will continue to provide CLIMAX customers with effective and regular postal services.
