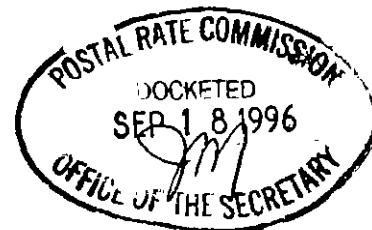
MOTION OF UNITED STATES POSTAL SERVICE


