NOTICE OF INQUIRY NO. 1 REGARDING POTENTIAL IMPROVEMENTS IN THE ORGANIZATION AND STRUCTURE OF DMCS PROVISIONS RELATED TO VARIOUS SPECIAL SERVICES

(November 14, 1996)

In addition to revisions to the Domestic Mail Classification Schedule (DMCS) reflecting substantive aspects of its filing in this case, the Postal Service has proposed several unrelated minor editorial changes.¹ The Commission believes these changes can serve as a starting point for broader improvements in the organization, format, and editorial presentation of the underlying DMCS, similar to those considered in the previous reclassification cases. Accordingly, participants are invited to comment on the matters set out below, and on related editorial or organizational issues that warrant consideration, no later than December 3, 1996.

The Commission contemplates publishing proposed revisions for comment prior to recommending specific DMCS language.

1. The DMCS Special Services numbering system differs from that used for the

classes of mail. In addition, gaps in the series are left unexplained. Comments are invited on the advisability of the following changes:

A. Adoption of a numbering system for the Special Services more closely resembling that used for the classes of mail, such as a series beginning with 700 or 900.

B. Use of a standard editorial device, such as the notation "[Reserved]," where the absence of a service offering or related fee schedule leaves a gap in the numbered series.

C. Replacement of the heading "Classification Schedules" with "Special Services."

Examples of the potential changes referred to in 1. A - C appear in Attachment A.

2. Editorial revisions and changes would improve the clarity of many of the Special Services provisions.² Comments are invited on the appropriateness of the following:

A. Establishing additional standard internal headings, such as "Restrictions on Availability."

B. Developing a consistent practice regarding the main content and level of detail appearing under each heading.

² For purposes of this docket, "editorial revisions" refer to changes in existing DMCS provisions or schedules affecting basic presentation, content and clarity. The phrases "minor editorial change" or "editorial change" are used interchangeably to refer to matters such as stylistic conventions, basic terminology, grammar and punctuation.

C. Moving the post office box fee schedule for facilities serving academic institutions, which now appears in § 10.031 of the main DMCS text, to the rate schedule section, with an appropriate cross-reference (similar to that in § 10.030) in the main text.

D. Revising the manner in which prorated fees for post office rental in § 10.031 are expressed (consider, for example, the references to "Full semi-annual fee" and "1-1/4 semi-annual fee").

E. Making minor editorial changes of the type noted in Attachment B.

3. Participants are invited to comment on the appropriateness of applying the following guidelines for implementing various editorial and organizational improvements. The Postal Service is requested to address whether it anticipates filing a request for reclassification within the next 6 months, of special or other services not included in this case.

A. Across-the-board application of a new numbering system, for the Special Services regardless of whether the underlying service or related schedule is substantively affected in this filing.

B. Adoption of editorial revisions in sections or schedules substantively affected by the Service's proposal (or by the Commission's enlargement of the docket), as noted in Attachment C.

C. Adoption of editorial revisions [*see* fn. 2] in sections or schedules not substantively affected in this filing, or deferral for consideration in a separate proceeding which the Postal Service expects to initiate shortly.

D. Adoption of minor editorial changes in any section or schedule,

regardless of whether the underlying service is substantively affected in this filing.

Attachment B

Supplement to Question No. 2.E.

Question 2.E. raises the possibility of making minor editorial changes. For discussion purposes, the following topics are put forth for comment. Examples cited here are illustrative only, and not an exhaustive list of potential changes.

1. Correction of grammatical errors and inconsistencies in punctuation (compare the use of "that provides" and "which provides" throughout the Special Services provisions).

2. Review of the accuracy and appropriateness of many of the references and stylistic conventions used throughout the Special Services provisions (compare, for example, the use of "prescribed" in § 222.32 with "specified" in § 222.41; note the repeated use of "sent under this classification schedule" throughout the Special Services provisions; consider, in § 5.010 and § 5.022, whether the "office of address" and "office of delivery" refer to the same office; consider also whether, in § 5.023, "notice of arrival" should be changed to "notice of attempted delivery."

3. Revision of terminology (for example, replacing "Second-class mail" in SS-1 with "Periodicals" and replacing references to "indemnity" in SS-9a and other places it appears with "compensation"). The Service's interest in changing "rents" to "uses" is also open for discussion under this topic.

4. Elimination of superfluous language (such as the term "later" in § 3.080).

Standardized presentation of various fee payments (compare § 160 versus § 260 versus § 362).

6. Extension of the Service's suggested elimination of gender-specific terms to other provisions (for example, revision of the phrase "for which he has not been paid" in SS-6, Collect on Delivery Service).
