**NOTICE OF THE UNITED STATES POSTAL SERVICE OF EXTENSION OF
 TWENTY-FIVE GLOBAL PLUS 1D NEGOTIATED SERVICE AGREEMENTS**
 (July 14, 2017)

The Postal Regulatory Commission (Commission) recently approved modifications to the Global Plus 1D agreements that are subject of the twenty-five dockets referenced above.¹

The modifications revised Article 12 of each of the agreements to state the following:

12. Term of the Agreement. (1) The USPS will notify the Mailer of the Effective Date of the Agreement within thirty (30) days after receiving the approval of the entities that have oversight responsibilities for the USPS. (2) The Agreement shall remain in effect until 11:59 p.m. on August 15, 2017, unless terminated sooner pursuant to Article 14 or Article 26. (3) The Mailer acknowledges that this Agreement is subject to regulatory oversight and such oversight might affect the Effective Date. (4) The USPS may, prior to the expiration of this Agreement, provide notice to the Mailer in accordance with Article 28 that this Agreement has been extended until a later date that is not later than 11:59 p.m. on September 30, 2017.

In the Postal Service's notice of filing for each of the twenty-five modifications, the Postal Service stated that the modification:

... revises Article 12 so that the agreement would remain in effect until August 15, 2017, unless terminated sooner pursuant to Article 14 or Article 26. In addition, the modification states that the Postal Service may, prior to the expiration of the Agreement, provide notice
