- 1. On February 17, 2017, the Postal Service filed Library Reference USPS-LR-PI2015-1/7, which includes the Postal Service's audit plan for the proposed internal service performance measurement system for market dominant products. Within the audit plan, the Postal Service states that it will contract the audit task to a third party. Please provide the following information:
 - a. The contractual statement of work describing the auditing and reporting tasks required of the contractor.
 - b. All documentation developed by the contractor explaining how it intends to perform audits and develop reports.
 - c. The "trial run" audit report provided by the contractor.
 - d. The first official audit report encompassing at least one quarter's data provided by the contractor.

RESPONSE:

- a) The Statement of Work (CIR.1.Q.1a.AuditSOW.pdf) is being filed as an electronic attachment to this response.
- b) The Postal Service's supplier, as part of a continuous improvement effort in the development of internal service performance measurement, is currently drafting its approach to conducting audits and developing audit reports, as a result of lessons learned in conducting the proof of concept ("trial run") audit report referenced in Question 1(c) below. The Postal Service intends to file this supplier documentation when it files the supplier's Quarter 3 audit report.
- c) The proof of concept audit report (CIR.1.Q.1c.Audit.Report.Concept.pdf), titled "Independent Validation" by ICF, was filed as an attachment to the Postal Service's June 12, 2017 response to this Commission Information
