NOTICE OF THE UNITED STATES POSTAL SERVICE REGARDING FILING
OF POST OFFICE SUSPENSION INFORMATION UPDATE
(November 8, 2017)

On page 151 of the FY 2016 Annual Compliance Determination (March 28, 2017), the Commission directed the Postal Service to update the information regarding Post Office suspensions presented in the “Suspensions” tab of USPS-FY16-33 within 40 days of the end of each quarter. The requested update for Quarter 4 of Fiscal Year 2017 is electronically attached to this notice as Excel file “FY17.Q4.Suspensions.Update.xls.”

There were originally 655 suspended Post Offices reported at the start of FY2017. After a review of databases, an additional 7 suspended offices were entered into the Postal Service’s tracking system after the FY began, bringing the total suspended offices number to 662. These additional 7 offices are listed below and in the attached Excel file.

As of the end of FY2017, 304 of these offices were officially discontinued, while 39 offices were re-opened, leaving 319 of the 662 offices in suspended status. There are an additional 14 offices that are scheduled for publication of final notification in the *Postal Bulletin* on Thursday, November 23, 2017, which will bring the suspended total to 305.

As a result of the above, the Postal Service is currently reviewing each of the remaining 305 suspended post offices to determine the proper course of action to be taken.

The various number totals noted above are reflected in the attached Excel file.
