**NOTICE OF UNITED STATES POSTAL SERVICE OF FILING
CERTAIN DATA CONCERNING EXPIRED AGREEMENT**
(November 29, 2017)

On June 29, 2016, the Postal Regulatory Commission (Commission) issued Order No. 3365, adding GEPS 6 as a new product to the competitive product list in the Mail Classification Schedule and designating the agreement that is the subject of the instant docket as the baseline agreement for the GEPS 6 product.¹ In Order No. 3365, the Commission also directed the Postal Service to file cost, volume, and revenue data associated with that agreement within 30 days of the agreement's expiration.² By modification approved by the Commission,³ the agreement remained in effect through October 31, 2017, and thereafter expired.

In response to Order No. 3365, the Postal Service hereby provides cost, volume, and revenue data associated with the expired agreement that is the subject of this docket. A redacted version of the data is filed with this Notice, while the unredacted version of the data is filed under seal. With respect to the nonpublic version of the data
