The Postal Service hereby gives notice of filing under seal an unredacted version of this notice, inputs for the GEPS NPR 15 product related to prices for Priority Mail Express International (PMEI), Priority Mail International (PMI), and First-Class Package International Service (FCPIS) that went into effect on January 26, 2020, as well as the relevant costs for FY2019 filed in the ACR2019 docket. The GEPS – NPR 15 PMEI, PMI, and FCPIS pricing incentives are set forth in the GEPS NPR 15 Management Analysis. To support the new incentive structure, the attached workpapers include formulas in the software tools, financial models, and the inputs used concerning PMEI, PMI, FCPIS, as well as costs.
