**NOTICE OF ERRATA TO RESPONSE OF THE UNITED STATES POSTAL SERVICE

The revised settlement workbook filed under seal with this filing is very similar to the settlement workbook that was included in the Postal Service's initial filing in this docket. Therefore, the Postal Service requests that the Commission consider the redacted version of the settlement workbook filed in this docket with the Postal Service's notice dated May 21, 2020, as representative of the revised settlement workbook filed with this notice.
