In compliance with Order No. 5558,¹ the United States Postal Service gives notice of filing Global Expedited Package Services – Non-Published Rates 15 (GEPS NPR 15) customer agreements with serial numbers ending 0018, 0021-0024, 0027-0041, and 0043-0045.² The effective dates for these twenty-three (23) agreements filed with this notice are listed below.

The Postal Service is filing these contracts with the Commission under seal. The agreements are derived from a common template³ and would appear essentially the same when redacted. Therefore, the Postal Service requests that the Commission consider the redacted version of the customer agreement with serial number NPR15-

FY20-JUN20-N-T0-0001, filed in this docket as Attachment 1 to the Postal Service's notice dated June 29, 2020,⁴ as representative of the contracts being filed.

The unredacted version of the inputs worksheets that were used to generate customer-specific rate tables for the agreement for which the Postal Service is providing notice are being filed with the Commission under seal. The inputs worksheets are very similar to the inputs worksheets that were included in the Postal Service's notice concerning the first group of GEPS – NPR 15 contracts filed in this docket. Therefore, the Postal Service requests that the Commission consider the redacted versions of the inputs worksheets filed in this docket with the Postal Service's notice dated June 29, 2020, as representative of the inputs worksheets filed with this notice.⁵

The Postal Service incorporates by reference the application for non-public treatment that was filed in conjunction with the Postal Service's notice of May 21, 2020, in this docket.⁶ The application protects from disclosure the information that has been redacted from the contracts and the inputs worksheets that the Postal Service is filing today with this notice.
