Pursuant to 39 U.S.C. § 407(d)(2), the U.S. Postal Service (Postal Service) is hereby filing (as Attachments 1-4) copies of the signature pages for the accessions of additional foreign designated postal operators to join the following multilateral data sharing agreement (DSA) into which the Postal Service and various other foreign designated postal operators have previously entered: "Agreement for the Electronic Exchange of Customs Data, Version 2 (8 June 2015)."¹ The Postal Service is also filing (as Attachment 5) a copy of the signature page for the accession of an additional foreign designated postal operator that joined the following multilateral DSA into which the Postal Service and various other foreign designated postal operators have previously entered: "Agreement for the Electronic Exchange of Customs Data."²



¹ This refers to the multilateral DSA 1 among the Postal Service and various foreign designated postal operators that is administered through the International Post Corporation (IPC); the Postal Service filed its signed copy with its letter to Mr. Stacy Ruble dated May 24, 2017. With this submission, the Postal Service is filing copies of the signature pages for the accessions of the designated operators of the Dominican Republic, the Faroe Islands, Greenland, and Peru, which accessions were all approved through IPC during late November.



With this submission, the Postal Service is filing a copy of the signature page for the accession of the designated operator of Brazil; this accession was approved through PUASP earlier this year, but its signature page was inadvertently omitted from earlier DSA filings.


