Re: Postmaster General DeJoy's 10-Year Plan

USPS, **as it was designed to function** and has succeeded in functioning – despite being hobbled by congressional mandate to prefund retiree healthcare benefits – is essential to LIFE IN AMERICA.

REJECT Louis DeJoy's plan,
REMOVE him as postmaster general, and
REPLACE him with a dedicated public servant who understands and appreciates the vital importance to our country and the world of the United States Postal Service.
