**AMAZON.COM SERVICES LLC's SECOND MOTION REQUESTING
ACCESS TO NON-PUBLIC MATERIALS UNDER PROTECTIVE CONDITIONS**
(March 17, 2022)

Pursuant to 39 C.F.R. § 3011.301, Amazon.com Services, LLC (ASL) respectfully requests access to the full, unredacted version of “USPS-RM2022-3-NP2” filed by the United States Postal Service (USPS) on March 14, 2022 in response to Chairman’s Information Request No. 5.¹

ASL requests access under the protective conditions established by the Commission to aid its evaluation of the issues in the above-captioned proceeding.
