

RESPONSE OF UNITED STATES POSTAL SERVICE WITNESS PLUNKETT TO QUESTIONS RAISED DURING HEARINGS

QUESTION 1: Does the response to MASA/USPS-T1-4 fail to address the impact of plex options? (Tr. 2/210-11)?

RESPONSE:

Yes. Mailing Online version 3.0 will not have the capability to combine in a single batch documents that have different plex characteristics, all other things being equal.

RESPONSE OF UNITED STATES POSTAL SERVICE WITNESS PLUNKETT TO QUESTIONS RAISED DURING HEARINGS

QUESTION 2: At Tr. 3/499, witness Plunkett indicated his lack of complete confidence regarding how the presort software used for Mailing Online sorted jobs that would not traditionally satisfy volume minimums for respective subclasses.

RESPONSE:

Typically, mail presortation software like that used in Mailing Online does not presort a mailing unless it has sufficient pieces to qualify for worksharing discounts, i.e. a 499 piece First-Class mailing would receive no presortation whatsoever. However, PostalSoft, the product used by Mailing Online, has been tweaked to permit any and all presortation to take place regardless of the number of pieces. The actual presortation achieved can and will be reported to the Commission. See Tr. 8/1770 (Docket No. MC98-1).
