

Val-Pak is a major user of the U.S. mails, particularly Standard (A) ECR Mail, in terms of both quantity of items mailed and costs of postage. It has an interest in the proposed rate and classification changes, and would be significantly affected by the rate and classification proposals of the United States Postal Service.

At this stage of the proceedings, it is unknown whether the Postal Service's request for classification changes and rate increases, as proposed, is in accordance with the Postal Reorganization Act. *See* 39 U.S.C. sections 3622 and 3623.

Val-Pak requests a hearing with respect to its interests and intends to participate actively in such a hearing.


