

**NOTICE OF INTERVENTION

Pursuant to Section 20 of the Rules of Practice and Commission Order No. 1279, the Parcel Shippers Association hereby files notice of its intervention in the above-captioned proceeding.

Intervenor will also take positions on and participate actively in the hearing with respect to such proposals as may be made by other parties to this proceeding to the extent that its interests so require.


