
The Postal Service has determined not to provide two copies of witness Rothschild's direct testimony from Docket No. MC98-1. At the January 12, 2000 hearing, Postal Service counsel was urging transcription of the Rothschild testimony, along with all of the Postal Service's direct testimony, as a means of facilitating citations in briefs. 
