(2) On the search screen, fill in the Docket No. and select Interventions as the Doc Type field. Type 'Baker' in the full-text search field and click submit. Check each intervention returned.
- 2. The first search will find documents containing the word 'postal' but exclude those containing the phrase 'postal service.' The second search will return all documents having instances of the word 'postal' not within two words of the word 'service.' A document containing both 'postal rate' and 'postal service' would be excluded from the first search but returned in the second.

Select Search from the banner and choose the Designations search type. Select the docket and enter 'poir' in the Non-Interrogatory Item field. Click Submit.

- 4. There is a linked index in the left frame of the PDF. Click the arrows to expand each subpart and select an item to go to that part of the document. The document's Table of Contents is also linked.
- 5. The first search returns the most records since it only requires documents to contain an instance of 'bprs' within ten words of 'cost coverage' and an instance of the word 'standard.' The second search requires documents to contain an instance of the word 'bprs' within ten words of 'cost coverage' and an instance of the word 'standard' within ten words of 'cost coverage.'
- 6. 'When' is a noise word, a common word ignored by the search engine.
