

Please see LR-I-168, WP-17 for the Fiscal Year 1998 volumes for on-site meter service. I took these volumes and multiplied them by the 1998 fees to arrive at the following revenues:

First Meter	\$7,233,450
Unscheduled Meter	594,128
Additional Meter	153,615
Meter Check In/Out of Service	853,918
TOTAL	\$8,835,110

To the best of my knowledge, these are the only sources of non-postage revenue for the meter program.


