TW/USPS-T17-24. What is the Postal Service's best estimate of the volume of non-carrier route presorted flats in FY96 and in FY98 respectively? If such information is available by class, please provide it.

Response:

Volumes for non-carrier route presorted flats for First-Class and Standard A/third-class for both years can be obtained from USPS LR-I-233, which is Material Supporting the Response of Witness Smith to POIR No. 4. See the spreadsheet VOL89-99.xls.

Volumes by shape and presort are not available for Periodicals/Second-Class. The available data for FY96 are from Docket No. R97-1, which is the billing determinants contained in USPS-LR-H-145 and in addition USPS-LR-H-129, page I-4, provides from ODIS that 90.86 percent of Second-Class pieces are flat shaped. The corresponding information for this docket for FY98 is USPS-LR-I-125 for the billing determinants and 92.2 percent of Periodicals pieces are flat shaped as per USPS-LR-I-81, page II-3.
