

NOTICE BY UNITED PARCEL SERVICE OF INTENT
TO CONDUCT ORAL CROSS-EXAMINATION OF
UNITED STATES POSTAL SERVICE WITNESS
HUNTER (USPS-T-5)
(April 6, 2000)

Pursuant to Section 30(e)(3) of the Commission's Rules of Practice, United Parcel Service ("UPS") hereby gives notice that it intends to conduct oral cross-examination of United States Postal Service witness Hunter on the following subjects: the decision to use PERMIT system and mailing statement/BRPW data to estimate Parcel Post revenue, pieces, and weight (USPS-T-5 at 1-2); how PERMIT system and mailing statement/BRPW data is collected (USPS-T-5 at 2-4); the Postal Service's procedures for verifying the accuracy of PERMIT system and mailing statement information (USPS-T-5 at 2-5); how the Postal Service processes and checks PERMIT system and mailing statement data both before, as, and after it is entered into the BRPW estimation system (USPS-T-5 at 2-4); data anomalies in the data set used by Mr. Hunter to develop BRPW estimates for Parcel Post (USPS-T-5 at 2-4); the relationship between the DRPW and BRPW systems in estimating Parcel Post revenue, pieces, and weight (USPS-T-5 at 2); revenue adjustments and conversions from PFY to GFY estimates (USPS-T-5 at 4-5); steps taken to insure that pieces sampled in the

DRPW system are not also counted in the BRPW system (USPS-T-5 at 2); and clarification of and expansion on Mr. Hunter's interrogatory responses.


