**DBP/USPS-110**. Refer to the response to DFC/USPS-41[h]. [a] If a special Priority Mail collection box has a Sunday collection time listed on it, would that provide an expectation that the box would be collected and the mail processed on Sunday? [b] In a similar manner, if a mailer was advised by a retail window clerk at an open Sunday facility that the mail would be processed, would that provide an expectation of processing?

#### **RESPONSE:**

[a] No. The customer expectation should be that the mail will be collected. While limited Sunday processing may be performed in some processing plants, it does not imply that all mail collected [or received] by the Postal Service will in fact be processed.

[b] Yes. It is likely that a "knowledgeable retail clerk" providing a customer with

information that mail would be processed would be correct with respect to Priority Mail

tendered on that particular day. However, it should not be construed that all of the

processed mail could be dispatched on Sunday (i.e., commercial air routings are limited

on weekends and do not provide service to the same number of origin/destinations on

Sunday as on a weekday), or that processing plants that are co-located with retail units

that are open on Sunday do in fact process Priority Mail on Sunday on a regular basis.
