MOTION OF THE UNITED STATES POSTAL SERVICE FOR LATE ACCEPTANCE  
OF RESPONSES OF WITNESS CAMPBELL TO INTERROGATORIES OF  
STAMPS.COM

The United States Postal Service hereby moves that it be permitted to file eight calendar days late the responses of witness Campbell to the following interrogatories of Stamps.com: STAMPS.COM-T39-7 through 9 and 11.

The interrogatories were filed on March 16, 2000; the responses were due to have been filed on March 30th. Neither the witness nor postal counsel were aware of the existence of these interrogatories until a phone call from Stamps.com counsel on Tuesday, April 4<sup>th</sup>. The Postal Service's R2000-1 docket document files, which contain copies of all documents served on the Postal Service, do not contain a copy. The Postal Service regrets the delay in responding to these interrogatories, but believes hat no party will be prejudiced by it.


Today, Postal Service counsel obtained a copy of a document which may be responsive to STAMPS.COM/USPS-T29-10. The Postal Service moves that it be allowed to file any objection to that interrogatory no later than April 11, 2000.


