(April 27, 2000)


The United States Postal Service hereby provides notice of the filing of a second set of errata to Library Reference I-168, Special Services Pricing Spreadsheets (Mayo, USPS-T-39). Changes are made to the spreadsheets for insurance, to reflect recent changes in witness Davis' costs for insurance (filed April 17, 2000), and post office box and caller service, to reflect recent changes in witness Kaneer's post office box counts (filed March 31, 2000). The changes do not affect any proposed fees, and affect revenue and cost coverage for post office box and caller service to a small degree, as well as the implicit cost coverage for unnumbered insurance. A revised electronic copy of LR-I-168 is also being filed with the Commission. A detailed description of the changes is attached.

**Summary of Changes to USPS-LR-I-168**

- WP-21, Pages 1 and 2: Replace entire pages to reflect revised witness Kaneer's revised box counts
- WP-32, Page 3 of 7: For unnumbered insurance, change After Rates Cost Per Piece (1.29 to 0.97), After Rates Cost Coverage (104.5% to 138.6%), and Before Rates Cost Per Piece (1.29 to 0.97) to reflect witness Davis' revised cost
- WP-32, Page 5 of 7: Replace columns 1, 4, 7, and 8 to reflect witness Kaneer's revised box counts
- WP-33, Page 1 of 4: To reflect witness Davis' revised costs, change Test Year Costs and Test Year Cost With Contingency for:  
Insurance - Numbered (\$1.99 to \$1.79, \$2.04 to \$1.83)  
Insurance - Unnumbered (\$1.26 to \$0.95, \$1.29 to \$0.97)  
Insurance - Volume Variable Cost Differential (\$0.73 to \$0.84, \$0.75 to \$0.86)
