PRESIDING OFFICER'S RULING GRANTING  
PARCEL SHIPPERS ASSOCIATION REQUEST  
TO ADJUST HEARING SCHEDULE

(Issued June 29, 2000)

Presiding Officer's Ruling No. R2000-1/80, issued June 22, 2000, established the schedule for hearings to receive the direct cases of participants other than the Postal Service. On June 27, 2000 Parcel Shippers Association asked that the schedule be adjusted to allow witness Zimmerman to appear between July 13 and July 19. That request is granted. Witness Zimmerman (PSA-T-1) is rescheduled to appear prior to witness Collins, on July 17, 2000.
