AISOP does know that as early as 1996 its contributing member Money Mailer requested membership information and postal updates that it posted on its limited access intranet site. Money Mailer continues to have posted as a permanent site accessible to its associates the membership application and general information about AISOP. This content is substantially the same as the content available at the internet address referenced in your question. This arrangement, like the information posted by Super Coups, simply involves AISOP

making its membership information available for reproduction by its members. AISOP does not have any link or unique access to any site or internet page occupied by any third person.

Super Coups makes this material available on its website but has also distributed this material to its franchisees by other methods in the past. AISOP would note that before Mail Coups, Inc. was acquired by ADVO, Inc. that it was a supporting member of AISOP and that the AISOP brochure and membership application were distributed to Super Coups' franchisees.
