PRESIDING OFFICER'S RULING SCHEDULING WITNESSES

(Issued August 16, 2000)

Presiding Officer's Ruling No. R2000-1/71 revised the procedural schedule to accommodate the submission of updated cost information. The schedule provided that hearings will be held beginning on August 23, 2000 to receive both supplemental testimony updating presentations to reflect the updated cost information, and testimony in rebuttal to the direct cases of participants other than the Postal Service. In addition, Presiding Officer's Ruling No. R2000-1/108 scheduled a hearing for August 22, 2000 to receive delayed testimony from United Parcel Service on the subject of the Bulk Revenue Pieces and Weights data.

The schedule for the appearance of the witnesses presenting this evidence is set forth in Attachment A. All witnesses have been assigned an appearance date.

Although no witnesses are currently scheduled for September 1, 2000, hearings still may have to be held on that date.

Participants intending to cross-examine are required to submit a notice of intent to cross-examine three days prior to the appearance of a witness. If no requests to conduct cross-examination of a particular witness are received, the testimony of that witness may be incorporated into the record by motion, without the actual presence of the witness. As discussed at the prehearing conference, hearings normally will continue until cross-examination of all scheduled witnesses has been completed.

Witnesses shall appear in the order shown in Appendix A absent an agreement to adjust the schedule to convenience witnesses and counsel.

RULING
