United Parcel Service ("UPS") hereby moves that further proceedings in this case be suspended until the omnibus rate case, Docket No. R2001-1, is concluded.

(November 8, 2001)

As stated in its recent filing in the rate case, UPS believes that suspension of proceedings in this case is necessary to allow the Commission and the parties to focus on the rate case. The Presiding Officer's comments at the prehearing conference in the rate case support the view that a delay in other proceedings is warranted, as the circumstances in which the Postal Service presently finds itself and the measures the participants will be expected to undertake to address those circumstances by working towards a settlement of the rate case potentially make Docket No. R2001-1 even more significant and more involved than usual. Omnibus rate cases always present daunting

challenges to the participants and the Commission. The need to engage in settlement negotiations adds to those challenges.²

Although the this complaint proceeding has been on the Commission's docket for an extended period, the present circumstances are exceptional. Moreover, this is an opportune time for this necessary delay. UPS has not yet filed its direct case, and therefore hearings would necessarily not come for several months anyway. If this case were to go forward, however, conflicts between the two proceedings would be almost inevitable.

Given the other demands confronting the Commission and the parties to this case, suspension of the proceedings seems appropriate. Suspending further proceedings here will enable the participants in this case to devote their time and resources to the more urgent issues confronting the Commission and the parties in the rate case.
