

**NOTICE OF INTERVENTION

Pursuant to Section 20 of the Rules of Practice and Commission Order No. 1186, the Parcel Shippers Association hereby files notice of its intervention in the above-captioned proceeding.

1.        Intervenor is an association consisting of approximately 200 members, primarily small businesses, from every section of the nation. Its members make use of parcel post service which is a part of Standard (B) class of mail. Additionally, the membership of the association makes use of First Class Mail, and of Standard (A).

Additionally, it reserves the right to participate actively with respect to the other proposals of the Postal Service should it develop that its interests so require. Intervenor will also take positions on and participate actively in the hearing with respect to such proposals as may be made by other parties to this proceeding to the extent that its interests so require.


