OCA/USPS-T5-7. Workpaper A-3, pages 4 through 14.1 indicates that many of the space and rental distribution key variabilities are either 70 or 80 percent. Please provide the derivation of each of the 70 and 80 variability percentages shown on those

pages. Include in each derivation cites to all source documents and the rationale for using each variability.

OCA/USPS-T5-8. Please refer to your workpaper A-3, Base Year 1996 Factor Report. State whether the capital amounts for equipment in column 1 on page 0.3 (used to calculate the capital factors) are the original equipment cost or the cost less depreciation.
