DFC/USPS-T25-4. Please refer to the four types of mail described in DFC/USPS-T32-2. Please confirm that some of the type (a) mail is produced by "individuals" (defined as "single human beings, as contrasted with a social group or institution").

DFC/USPS-T25-5. To the extent that customers who presently prepare OCR-readable, non-bar-coded single-piece First-Class letters or cards switched to an addressing method such as handwriting that could not be fully resolved by an OCR, would you expect that processing costs would increase? Please explain your answer.

DFC/USPS-T25-6. To the extent that customers who presently prepare mail that can be processed on automated sorting equipment switched to envelope or card materials that, due to their color or surface texture, reduced the percentage of pieces that could be processed on automated sorting equipment, would you expect that processing costs would increase? Would the reverse be true, too? Please explain your answer.
