

RESPONSE OF WITNESS COCHRANE TO INTERROGATORY
OF THE UNITED PARCEL SERVICE REDIRECTED FROM
THE UNITED STATES POSTAL SERVICE

UPS/USPS-12. Refer to the Postal Service's response to UPS interrogatories redirected from Witness Tayman UPS/USPS-T6-7 (erroneously identified by the Postal Service as UPS/USPS-T6-6).

- (a) Provide the proportion of volume that is not Priority Mail and that is processed at those Priority Mail Processing Centers that are now operated by the Postal Service.

RESPONSE:

- (a) It is my understanding that only two (2) of the original ten (10) PMPCs – Philadelphia PMPC and Pittsburgh PMPC – will be processing mail other than Priority Mail, starting in January 2002. The proportion of volume that is not Priority Mail and that will be processed in those facilities is approximately 10% - 15% of those facilities total volume.


