**MOTION FOR CONSIDERATION OF STIPULATION AND AGREEMENT
(December 7, 2001)**

The United States Postal Service hereby submits signature pages executing the Stipulation and Agreement filed by the Postal Service with its Request in this Docket. The executed Stipulation and Agreement represents a negotiated settlement by the signatories of all issues raised in this proceeding. The signatories request that the Postal Rate Commission issue an Opinion and Recommended Decision that is based upon the evidence submitted by the Postal Service with its Request and that recommends the Domestic Mail Classification Schedule change proposed therein.¹ A signed declaration from witness Koroma, so that his testimony may be entered into the record of this proceeding, will be provided separately.

The following participants in this proceeding have authorized the Postal Service to represent that each supports this motion and the Stipulation and Agreement: American Business Media; Association for Postal Commerce; Magazine Publishers of America; and the Office of the Consumer Advocate.
