RESPONSE OF UNITED STATES POSTAL SERVICE WITNESS SHAW TO QUESTIONS VAL-PAK RAISED DURING HEARINGS

Question of Val-Pak at Tr. 3/298:

Q If there were changes to how IOCS Handbook F-45 handles DALs since the information was provided in J-34 through June 30, 2000, could you provide those as a library reference?

RESPONSE:

All Statistical Program (SP) Letters associated with IOCS data collection during

FY1999 and BY2000 are provided in library reference USPS-LR-J-34/R2001-1.

From June 30, 2000 through September 24, 2001, there is one SP Letter that

updates the instructions provided in the Handbook F-45 regarding DALs; SP

Letter #3, FY2001, dated December 18, 2000. The applicable portion reads:

Bound Printed Matter (BPM) can be mailed with Detached Address Labels (see

DMM55 A060.1.4). When "J. Bound Printed Matter" is selected in Q23B, the

warning message that "Only periodicals or Std. A mail should have detached

address cards" is eliminated.

Question of Val-Pak at Tr. 3/311:

Q Mr. Chairman, insofar as we've now figured out what the confusion was; that in fact it is possible to do what we have previously asked for, for that subset of tallies that are single piece tallies as Witness Shaw has explained it today, we would ask the Postal Service to provide that distribution by weight at its earliest convienience if it would do that.

RESPONSE:

The direct tally distribution of flat-shaped ECR Standard Mail weight that is

associated with a detached address label is displayed in Table 1. IOCS is not a

volume or weight measurement system; distributions of tallies do not represent

distributions of mailpieces.

Reference. 3/314:

Q But what I'm trying to get at is if the reading is in the office. I mean, it's the in-office cost system. If it's in the office, I understand they would observe it. I'm asking if it was in the parking lot loading a vehicle would it be observed outside of the building, or would they wait until the person came back.

Question of Val-Pak at Tr. 3/315:

Q Would it be difficult to provide an answer to that question, as well as to whether tallies are taken outside in the parking lot where the vehicles are loading or whether they wait until the employee comes back in?

RESPONSE:

During an IOCS carrier reading the data collector is asked to determine if the

selected employee can be located on the premises, regardless of whether the

selected employee is clocked to office or street time. On the premises means

that either the employee can be located in the facility or in the immediate area.

When the data collector locates the selected employee on the premises and in

this case, the employee is loading a vehicle outside in the parking lot, the data

collector must conduct the reading in the parking lot to complete the reading.
