UNITED STATES POSTAL SERVICE NOTICE OF FILING OF REVISIONS TO
EXHIBITS USPS-28B AND USPS-28E (ERRATA)

The United States Postal Service hereby gives notice that it is filing today revised versions of the following two Exhibits that accompany the direct testimony of witness Moeller (USPS-T-28):

Exhibit USPS-28B: Summary of Estimated Test Year After Rates Finances –
Revenue and Volume Variable Cost

Exhibit USPS-28E: Summary of Estimated Test Year After Rates Finances –
Revenue and Incremental Costs

The revised Exhibits USPS-28B and USPS-28E supersede the original versions that were attached to USPS-T-28, filed on September 24, 2001.

Exhibit USPS-28B

Presiding Officer's Information Request No. 8, Question 8 was filed on January 9, 2002. It concerned Exhibit USPS-28B, and noted an inconsistency with figures presented in USPS-T-32, page 28. The attached revised Exhibit USPS-28B reconciles that inconsistency.

At the same time, the revised Exhibit USPS-28B is corrected to conform to previously filed special services fee revenue estimates of witness Mayo (USPS-T-36).

The attached revisions to Exhibit USPS-28B also incorporate errata to USPS Library Reference J-167 filed in connection with the testimony of witness Patelunas (USPS-T-12) on October 31, 2001.

The attached revised Exhibit USPS-28B results in a net change in the total revenue reported of about \$500,000. It also corrects the minor international volume error identified in POIR No. 5, Question 4.

The net effect of all of the revisions to this Exhibit is to reduce the TYAR surplus from \$33 million to \$21 million.

Exhibit USPS-28E

Exhibit E is changed to incorporate the revised revenue estimates in amended Exhibit USPS-28B.
