## PRESIDING OFFICER'S RULING ESTABLISHING THE INITIAL PROCEDURAL SCHEDULE

(Issued October 29, 2002)

Attached as Appendix A is the Initial Procedural Schedule for this case. The schedule is designed to balance the desirability of expedition and the need to provide all participants with a fair opportunity to explore relevant issues.

The schedule takes account of the requests for discovery made during the Prehearing Conference. See Tr. 1/22-23. It allows for follow-up interrogatories before hearings, which are set to begin after the Thanksgiving holiday. It is my current intention to schedule the appearance of Capital One Services, Inc. witnesses on the first day of hearings, December 3, 2002, and Postal Service witnesses on subsequent days.

The schedule lists alternative procedural dates depending on whether any participant determines to file evidence in opposition to the request. Based on the representations of counsel at the prehearing conference, it is possible that participants may be able to effectively present their views through legal briefs, without presenting testimony in opposition to the Request. The schedule also reflects that the holiday season falls during this case. Discovery on testimony in opposition, or if there is no such testimony the period for preparation of reply briefs have been extended. The time allotted should enable all participants to carefully explore relevant issues while allowing the Commission to arrive at a prompt decision on the joint Postal Service/Capital One request.
