**NOTICE OF THE UNITED STATES POSTAL

The United States Postal Service hereby gives notice of the below-listed revisions to the Rebuttal Testimony of Rachel Tang (USPS-RT-2), originally filed on September 9, 2004. All of these revisions relate to matters previously discussed in discovery responses, and they have no material impact on the points made in the testimony. Most of the revisions reflect the effects of the correction of minor errors in the database used to generate Tables 1-4. Some of those errors had been identified and corrected at the time of the original filing on October 15 of USPS-LR-1/C2004-1, while others were identified subsequently, and will be corrected in a revised version of that library reference being filed separately.

Page 5	Table 2	Revised to reflect corrected data. (Note: The order of publications in Tables 2-4 changed slightly to maintain percentage change column in descending order.)
	Line 9	Change "23.2" to "22.9", and change "24.1" to "23.7"
Page 6	Table 3	Revised to reflect corrected data
	Line 5	Change "one publication" to "two publications"
	Table 4	Revised to reflect corrected data
Page 7	Line 7	Change "33" to "29"
Page 10	Lines 2-3	Change "the Periodicals rate markup index" to "an index of Periodicals rates, at a constant markup index." (Docket No. C2004-1, TW et al.-T-1, at 10)"
