USPS-LR-K-72 REVISIONS (MAY 31, 2005)

Explanation of 5/31/05 revisions:

The test year incremental cost model (before and after rates) was rerun using the revised final adjustments filed by witness Page (USPS-T-23) on 5/24/05. In addition, the test year Priority Mail product specific costs inputs for mail processing were reduced by the amount coming from the mail processing cost pool for PMPCs (as shown in workbook IC3-1.xls), for the reason specified in pages 12-13 in my testimony. The incremental cost model filed previously was inconsistent with that portion of my testimony.
