UNITED STATES POSTAL SERVICE NOTICE OF ERRATA
CORRECTING FEE SCHEDULE 1000 IN BOTH POSTAL SERVICE REQUEST,
ATTACHMENT A, AND STIPULATION AND AGREEMENT, ATTACHMENT A
(August 3, 2005)

In the Postal Service's response to Presiding Officer's Information Request No. 6, Question 1,¹ the Postal Service acknowledged an error in Attachment A of the Request in this docket.² As filed, Attachment A, Fee Schedule 1000 (Miscellaneous Fees), erroneously presented the current fee for Periodicals, Original Entry, as \$ 475.00. The proposed fee was erroneously presented as \$500.00. As noted in the answer to POIR No. 6, the current and proposed fees were correctly stated in Postal Service witness Taufique's testimony (USPS-T-28), in Exhibit USPS-28A, p. 56. In Attachment A, page 83, the correct fees should therefore be presented as follows:
