NOTICE OF THE UNITED STATES POSTAL SERVICE OF FILING  
A REVISED LIBRARY REFERENCE USPS-LR-L-43 [ERRATA]  
(June 28, 2006)

The United States Postal Service hereby files notice that today it is filing a revised Library Reference USPS-LR-L-43, *Flats Mail Processing Cost Models*, a Category 2 library reference sponsored by witness Miller (USPS-T-20). The revised cost models reflect two changes to the piggyback factors. First, the models are revised to reflect the revisions to the APPS and SPBS/LIPS piggyback factors that were recently made in USPS-LR-L-52. See Notice of the United States Postal Service of Filing of Revisions to Library Reference USPS-LR-L-52 (June 15, 2006). Second, the models were errantly using the APPS piggyback factor without REC costs included; the revised models correctly use the APPS piggyback factor with REC costs included (as provided in the revised USPS-LR-L-52). Finally, the revised models also correct the premium pay factors, which were incorrect at the fifth or sixth decimal point.

The revised piggyback factors were entered on pages 32, 67, and 106 of the library reference, and the revised premium pay factors were entered pages 31, 66, and 105 of the library reference. The revisions to the premium pay factors have no effect on the model results. These revisions to the piggyback factors affected the following pages of the library reference:

- FCM Presort: pgs 1-2, 4-9, 11, 13, 15, 19, 21, 23, and 27
- Per Outside County: pgs 39-40, 42, 44, 46, 48, 50, 52, 54, 56, 58, and 60
- Std Mail Regular: pgs 74-75, 77, 79, 81, 83, 85, 87, 89, 91, 93, 95, 97, and 99

The revised library reference replaces the original in its entirety. Copies are also on file with the Postal Service library.
