NOTICE OF THE UNITED STATES POSTAL SERVICE OF FILING  
A REVISED LIBRARY REFERENCE USPS-LR-L-45 [ERRATA]  
(July 28, 2006)

The United States Postal Service hereby files notice that today it is filing a revised Library Reference USPS-LR-L-45, *Standard Mail Hybrids and Parcels Cost Estimates*, a Category 2 library reference sponsored by witness Miller (USPS-T-20). This library reference was originally filed with an addendum that corrected erroneous PPSM and SPSM piggyback factors. Further revisions are now being made: 1) the revised flats mail processing unit cost estimates by rate category from USPS-LR-L-43, which was revised on June 28, 2006, have been added to page 1; 2) corrected premium pay factors, which had been incorrect at the fifth or sixth decimal point, have been added to page 28;<sup>1</sup> 3) revised APPS and SBPS/LIPS piggyback factors have been added to page 29;<sup>2</sup> and 4) a corrected premium pay factor has been added to page 38.

These revisions have been incorporated into the addendum Excel file that was originally filed (which as noted above had corrected erroneous PPSM and SPSM piggyback factors), and affect the following pages of the model: pages 1, 2, 4, 6, 8, 10,

<sup>2</sup> Revisions to the APPS and SPBS/LIPS piggybacks factors are required for two reasons. First, the piggyback factors were revised in USPS-LR-L-52. See Notice of the United States Postal Service of Filing of Revisions to Library Reference USPS-LR-L-52 (June 15, 2006). Second, the L-45 model was errantly using the APPS piggyback factor without REC costs included; the revised model correctly uses the APPS piggyback factor with REC costs included (as provided in the revised USPS-LR-L-52).

12, 14, 16, 18, 20-23, 28, 29, 38, and 40-47. A revised addendum Excel file, incorporating both the PPSM and SPSM piggyback factor errata and the errata that is the subject of this notice, is being filed today, and hardcopies of those pages that are affected by the entirety of the errata are provided in the addendum to the hardcopy library reference.

Copies are also on file with the Postal Service library.
